1- TRADEMARK SEARCH

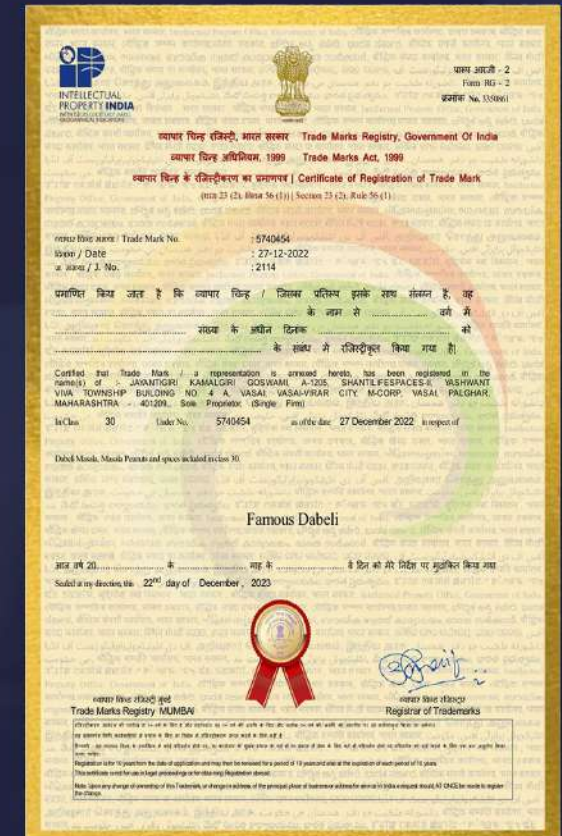
Searching of Trademark Name and Class for your goods/services brand to ensure the availability of your Brand Name and Logo.

2- FILING AND ACCEPTANCE

Filing the specific trademark in your matching class and getting acceptance from the tribunal for registration.

3- TRADEMARK REGISTRATION CERTIFICATE

If there is no Objection and opposition found within the prescribed time so your Trademark Certificate will be eligible to download from the Govt Official Website.



Note: Objection and opposition are subject to pass under the IPR Tribunal Examiner. We don't provide any surety if any objection or opposition arrives. Objection can be cleared through the examination reply.
